Final Order Entered: 1 . Kentucky-American is relieved of the obligation set forth in the December 23, 2014 Order to file a witness list. 2. The sewer service rates set forth in Kentucky-American's original application are denied. 3. Kentucky-American's request for four annual rate increases based on Commission Staff's findings that Kentucky-American could justify a \$185,643 increase in the revenue requirement for an overall revenue of \$489,559 is granted. 4. The Phase 1 rates set forth in Appendix A to this Order are approved for service rendered by Kentucky-American on and after the date of this Order. 5. The Phase 2 rates set forth in Appendix B to this Order are approved for service rendered by Kentucky-American effective the day after the first anniversary of the date of this Order. 6. The Phase 3 rates set forth in Appendix C to this Order are approved for service rendered by Kentucky-American effective the day after the second anniversary of the date of this Order. 7. The Phase 4 rates set forth in Appendix D to this Order are approved for service rendered by Kentucky-American effective the day after the third anniversary of the date of this Order. 8. One month prior to the effective date of the Phase 2, Phase 3, and Phase 4 rates, Kentucky-American shall publish a one-time notice following the requirements of 807 KAR 5:076, Section 5.
