4. No earlier than 30 days, but no later than 20 days prior to implementation of the rates set forth in Appendix B, Western Mason shall publish notice of the Phase 2 rates at least once in a newspaper of general circulation in its territory or place an insert in bills rendered to its customers. Notice shall be in the form set forth in Appendix D to this Order. Western Mason shall file with the Commission proof of publication no later

than ten days after publication of the notice. 5. Within 20 days of the date of this Order, Western Mason shall file revised tariff sheets with the Commission, using the Commission's electronic Tariff Filing System, containing the rates set forth in the Appendix A and B to this Order. 6. In all future reporting periods, Western Mason shall use the "PSC Approved Service Life" set forth in Appendix C to this Order for the listed asset groups when calculating and reporting depreciation for all reporting periods after the date of this Order.
