Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky, on October 7, 2015, at 1:00 p.m., Eastern Daylight Time, to submit itself to examination on the application of its Fuel Adjustment Clause ("FAC") from November 1, 2014, through April 30, 2015. Neither opening statements nor summaries of pre-filed testimony will be permitted. 2. Not less than seven days and no more than 21 days prior to the scheduled hearing, LG&E shall publish in a newspaper of general circulation in each area in which it serves notice of the purpose, time, place, and date of the scheduled hearing.
