- 10/12/16 Order Entered: 1. Duke Kentucky's petition for confidential protection for its Fuel Cost Policy, filed in response to Commission Staffs PHDR-5, is granted. 2. The materials for which Duke Kentucky has been granted confidential treatment should not be placed in the public record or be made available for public inspection for a period of ten years, or until further Order of this Commission. 3. Use of the materials in question in this proceeding shall be in compliance with 807 KAR 5:001, Section 13(9). 4. Duke Kentucky shall inform the Commission if the materials in question become publicly available or no longer qualify for confidential treatment. 5. If a non-party to this proceeding requests to inspect materials granted confidential treatment by this Order, then Duke Kentucky shall have 20 days from receipt of written notice of the request to demonstrate that the materials still fall within the exclusions from disclosure requirements established in KRS 61.878. If Duke Kentucky is unable to make such demonstration, the requested materials shall be made available for inspection. 6.
