If a party requests a hearing or informal conference, then the party shall make the request in its written comments and state the reason why a hearing or informal conference is necessary. 4. If Commission Staff finds that Harrison County's financial condition supports a higher rate than Harrison County proposes or the assessment of an additional rate or charge not proposed in Harrison County's application, Harrison County in its response to the Commission Staff Report shall also state its position in writing on whether the Commission should authorize the assessment of the higher rate or the recommended additional rate or charge. |
