Hardin District shall require construction to be inspected under general supervision of a licensed professional engineer with a Kentucky registration in civil or mechanical engineering to ensure that construction work is done in accordance with contract drawings and specifications and in conformance with best practices of construction trades involved in the project. 5. Hardin District shall file documentation of total costs of project including cost of construction and all other capitalized costs, (e.g., engineering, legal, and administrative) within 60 days of the date that construction authorized under this CPCN is substantially completed. Construction costs shall be classified into appropriate plant accounts in accordance with

the Uniform System of

Accounts for water utilities prescribed by the Commission. 6. Hardin District shall file a copy of the "as-

built" drawings and a certified

statement that the construction has been satisfactorily completed in accordance with the contract plans

and specifications within 60 days of the substantial completion of the construction certificated herein.
