Northern District shall not begin construction on the project until the USACE and Fort Thomas have issued their permits for this project. Northern District shall file a copy of the permit, certification, approval, or document within ten days of obtaining each permit, certification, approval or document, 5. Northern District shall require construction to be inspected under the general supervision of a licensed professional engineer with a Kentucky registration in civil or mechanical engineering to ensure that the construction work is done in accordance with contract drawings and specifications and in conformance with best practices of construction trades involved in project. 6.
