11/10/16 Final Order Entered: 1. US 60 District is granted a CPCN to proceed with the proposed construction as set forth in its application. 2. US 60 District shall notify the Commission prior to performing any additional construction not expressly authorized by this Order. 3. Any deviation from the construction approved by this Order shall be undertaken only with the prior approval of the Commission. 4. US 60 District shall require construction to be inspected under the general supervision of a licensed professional engineer with a Kentucky registration in civil or mechanical engineering to ensure that the construction work is done in accordance with the contract drawings and specifications and in conformance with the best practices of the construction trades involved in the project. 5. US 60 District is authorized to enter the proposed Assistance Agreement with KIA and, under the terms of the Assistance Agreement, to borrow from KIA an amount not to exceed \$2,300,000 to be repaid over a 20-year period at an interest rate of 1.75 percent per annum with a loan-servicing fee of 0.20 percent of the annual outstanding loan balance payable to KIA with each interest payment. 6. Within 30 days of executing its proposed Assistance Agreement with KIA, US 60 District shall file with the Commission an executed copy of the Assistance Agreement.
