Kentucky Power's continued use of the existing base fuel cost of \$.02725 per kWh is approved. 3. Kentucky Power shall be allowed to continue using the natural gas prices as published in Platts Gas Daily in its PUE calculation. 4. Beginning with its first FAC filing following the date of this Order, Kentucky Power is allowed to collect \$51,330.50 through its FAC each month for four months for a total of \$205,322.

Not less than seven days nor more than 21 days prior to the scheduled hearing, Kentucky Power shall publish in a newspaper of general circulation in each area in which it provides service notice of the purpose, time, place, and date of the scheduled hearing. 3. Kentucky Power shall file with the Commission no later than April 17, 2017, proof
