days of the date of this Order. 6. Upon payment of \$5,000 by Inter-County and the filing of Inter-

revised safety manual, this case shall be closed and removed from the Commission's docket without

further Order of the Commission.

evidence on the adequacy, safety, and reasonableness of its practices related to the construction, installation, and repair of electric facilities as they relate to the facts of this case and whether such practices require revision as related to this incident. 6. Any requests for an informal conference with Commission Staff shall be set forth in writing and filed with the Commission within 20 days of the date

of this Order.
