Bronston's proposed plan of financing is approved. 3. Bronston is authorized to enter into a promissory note with RD in the amount of \$1,380,000, maturing over a 40-year period, at an interest rate not to exceed the lower of 1.875 percent per annum and be equal to the lower of the rate in effect at the time of loan approval, or the interest rate in effect at the time of closing. 4. The proceeds from the

promissory note shall be used only for the purposes specified in Bronston's application. 5. Bronston shall obtain approval from the Commission prior to performing any additional construction not

expressly authorized by this Order. 6. Notwithstanding ordering paragraphs 4 and 5, if surplus funds remain after the approved construction has been completed, Bronston may use such surplus to construct additional plant facilities if RD approves of the use and the additional construction will not result in a change in Bronston's rates for service. Bronston shall provide written notice of this additional construction in accordance with 807 KAR 5:069, Section 4. 7. Bronston shall file with the Commission

documentation of the total costs of this project, including the cost of construction and ail other capitalized costs, (e.g., engineering, legal, and administrative) within 60 days of the date that

construction is substantially completed.
