Final Order Entered: 1. Northern Kentucky is granted a CPCN to proceed with the proposed construction as set forth in its application. 2. Northern Kentucky shall notify the Commission prior to performing any additional construction not expressly authorized by this Order. 3. Any deviation from the construction and repairs approved by this Order shall be undertaken only with the prior approval of the Commission. 4. Northern Kentucky shall require construction to be inspected under the general supervision of a licensed professional engineer with a Kentucky registration in

civil or mechanical engineering to ensure that the construction work is done in accordance with the contract drawings and specifications and in conformance with the best practices of the construction trades involved in the project. 5. Northern Kentucky shall submit an application to the Commission prior to issuing any securities that require approval pursuant to KRS 278.300. 6. Northern Kentucky shall file with the Commission documentation of the total costs of this project, including the cost of construction and repairs and all other capitalized costs, (e.g., engineering, legal, administrative) within 60 days of the date that construction authorized under this CPCN is substantially completed. Construction and repair costs shall be classified into appropriate plant accounts in accordance with the Uniform System of Accounts for water utilities prescribed by the Commission.
