Final Order Entered: 1. The findings contained in the Staff Report are adopted and incorporated by reference into this Order as if fully set out herein. 2. The general service rates proposed by Cawood District are denied. 3. The rates set forth in the Appendix to this Order are approved for services rendered by Cawood District on and after the date of this Order. 4. The nonrecurring charges as set forth in Appendix to this Order are approved. 5. Within 20 days of the date of this Order, Cawood District shall file with this Commission, using the Commission's electronic Tariff Filing System, new tariff sheets setting forth the rates and charges approved herein and their effective date, and stating that the rates and charges were authorized by this Order. 6. Cawood District shall use the mid-point of the depreciable lives of the National Association of Regulatory Utility Commissioners ranges, as proposed by Staff, to depreciate water plant assets for accounting purposes in all future reporting periods. No adjustment to accumulated depreciation, or retained earnings should be made to account

for this change in the accounting estimate.
