Kentucky Power Company (Kentucky Power) shall appear in Hearing Room 1 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky, on October 9, 2018, at 9:00 a.m. Eastern Daylight Time, to submit itself to examination on the application of its Fuel Adjustment Clause (FAC) from November 1, 2017, through April 30, 2018. Neither opening statements nor summaries of pre-filed testimony will be permitted. 2. Not less than 7 days and no more than 21 days prior to the scheduled hearing, Kentucky Power shall publish, in a newspaper of general circulation in each area in which it serves, notice of the purpose, time, place, and date of the scheduled hearing. In addition, the notice of hearing shall include the following statement: "This hearing will be streamed live and may be viewed on the PSC website, psc.ky.gov." 3. Kentucky Power shall file with the Commission no later than October 8, 2018, proof of publication of its notice for the hearing. 4. The official record of the proceeding shall be by digital video recording only. 5. a. The information requested in the Appendix to this Order is due no later than 14 days from the date of entry of this Order. Responses to requests for information in paper medium shall be appropriately bound, tabbed, and indexed. Electronic documents shall be in portable document format (PDF), shall be searchable and shall be appropriately bookmarked.
