Final Order Entered: 1. Whitley County District's motion to incorporate the record of Case No. 2017-00068 is granted. 2. Whitley County District is granted a CPCN to proceed with the proposed construction as set forth in its application. 3. Whitley County District shall notify the Commission prior to performing any additional construction not expressly approved by this order. 4. Any deviation from the construction approved by this order shall be undertaken only with the prior approval of the Commission. 5. Whitley County District shall require construction to be inspected under the general supervision of a licensed professional engineer with a Kentucky registration in civil or mechanical engineering to ensure that the construction work is done in accordance with the contract drawings and specifications and in conformance with the best practices of the construction trades involved in the project. 6. Whitley County District is authorized to enter into the proposed Assistance Agreement with KIA and, under the terms of the Assistance Agreement, to borrow from KIA an amount not to exceed \$37,204.00 to be repaid over a 20-year period at an interest rate of 0.75 percent per annum with a loan servicing fee of 0.25 percent of the annual outstanding loan balance payable to KIA with each interest payment. 7. Within 30 days of executing its proposed Assistance Agreement with KIA, Whitley County District shall file with the Commission an executed copy of the Assistance Agreement.
