Within 20 days of the date of this Order, Nixutil Association shall file with this Commission, using the Commission's electronic Tariff Filing System, new tariff sheets setting forth the rates and charges approved herein and their effective date, and stating that the rates and charges were authorized by this Order. 5. Nixutil shall include in the new tariff sheets language reflecting how the approved late fee will be applied. 6. The revenues collected pursuant to the interim rate established by the April 1, 2019 Order in this matter are no longer subject to refund. 7. No refund of the interim rate is due because the rates approved in this order are higher than the interim rates. 8. Nixutil is relieved of the obligation in the April 1, 2019 Order that it maintains records of the interim rates to determine the amounts to be refunded and to whom any refund of the interim rate is due. 9.
