Pursuant to 807 KAR 5:001, Section 8(9), within seven days of entry of this Order, EKPC and each of its Member Cooperatives shall file a written statement, with a copy to parties of record, that it waives any right to service of Commission orders by United States mail and that it or its authorized agent possesses the facilities to receive electronic submissions. 4. Unless a party granted leave to intervene states its objection to the use of electronic filing procedures in a motion for intervention, the party shall: and the service of all papers, including Orders of the Commission, by electronic means; and b. Within seven days of the entry of an Order of the Commission granting its intervention, file with the Commission a written statement that it waives any right to service of Commission orders by United States mail and that it or its authorized agent possesses the facilities to receive electronic submissions. 5. If a party objects to the use of electronic filing procedures and the Commission determines that good cause exists to excuse that party from the use of electronic filing procedures, service of documents on that party and by that party shall be made in accordance with 807 KAR 5:001, Section 4(8).
