06/07/19 Order Entered: 1. This proceeding is initiated to determine whether a vacancy existed on the Sandy Hook Water District's Board of Commissioners for more than 90 days. 2. Sandy Hook Water District is made a party to this proceeding. 3. Any party filing documents with the Commission shall serve a copy of those documents upon all other parties. 4. a. The information requested in Appendix B to this Order is due within 14 days of entry of this Order. Responses to requests for information shall be appropriately bound, tabbed, and indexed and shall include the name of the witness responsible for responding to the questions related to the information provided, with copies to all parties of record, and the original and five copies to the Commission. b. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry. c. A party shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect.
