The general service rates proposed by Knott District are denied. 3. The Phase 1 rates set forth in the Appendix to this Order are approved for service rendered by Knott District on and after the date of this Order. 4. The Phase 2 rates set forth in the Appendix to this Order are approved for service rendered by Knott District effective on the first anniversary of the date of this Order. 5. Within 20 days of the date of entry of this Order, Knott District shall file with this Commission, using the Commission's electronic Tariff Filing System, new tariff sheets setting forth the rates and charges approved herein and their effective date and stating that the rates and charges were authorized by this Order. 6. One month prior to the effective date of the Phase 2 rates, Knott District shall publish notice with the rate schedule as set forth in the Appendix to this Order. 7. Knott District shall review and update its tariff to reflect the current costs to install new water taps.
