Pursuant to KRS 278.255, a competent, qualified, and independent firm shall be retained to perform a full and comprehensive audit of the infrastructure engineering, facilities planning, construction , operation, and maintenance practices of Grayson RECC. 4. Pursuant to KRS 278.255(3) , Grayson RECC shall bear the cost of this audit. 5. Consistent with 807 KAR 5:013, Commission Staff shall take all actions necessary for the selection and retention of a competent, qualified and independent firm to conduct the audit of the infrastructure engineering, facilities planning, construction, operation , and maintenance practices of Grayson RECC. 6. Upon completion of the audit, Commission Staff shall file with the Commission a written report of the auditing firm 's findings and conclusions and all documents that were assembled or produced as a result of the audit.
