Clark Energy is granted a deviation from the requirements of 807 KAR 5:001, Section 12(1)(a) and 807 KAR 5:001, Section 16(1)(b)(2), (4)(j)-(s), 4(v), and 5(b)-(d). 3. Clark Energy's 20184 and 20195 annual reports are incorporated by reference into the record of this proceeding. 4. Requests for intervention shall be filed no later than May 29, 2020. 5. All requests for information to Clark Energy shall be filed no later than June 12, 2020. 6. Clark Energy shall file responses to requests for information no later than June 22, 2020. 7. Any written comments regarding Clark Energy's application shall be filed no later than June 29, 2020. 8. The case shall be submitted for a decision on July 1, 2020.
