Within 20 days of the date of entry of this Order, Nicholas District shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein. 5. Nicholas District shall file an application for a traditional adjustment in rates or an alternative rate adjustment within one year of the date of entry of this Order. 6. Nicholas District shall file a response to the January 29, 2020 Periodic Compliance Inspection Report with the Commission's Division of Inspections within ten days of the date of this Order. 7. This case is hereby closed and removed from the Commission's docket.
