05/26/20 Order Entered: 1. This proceeding is established to investigate the reasonableness of Pendleton District's proposed Amended Contract. 2. Pendleton District's proposed Amended Contract is suspended for five months, from May 31, 2020, up to and including October 28, 2020. 3. Pendleton District shall file responses to the request for information attached as an Appendix to this Order within 15 days of the date this Order is entered. 4. Unless otherwise ordered by the Commission, the procedures set forth in 807 KAR 5:001, Section 8, related to service and electronic filing of papers shall be followed in this proceeding. 5. Pursuant to 807 KAR 5:001, Section 8(9), within seven days of this Order, Pendleton District shall file by electronic means a written statement that it waives any right to service of Commission Orders by United States mail and that it or its authorized agent possesses the facilities to receive electronic submissions. The paper original shall be filed within 30 days of the ending of the current state of emergency caused by COVID- 19.
