Larue District #1 is authorized to issue water revenue bonds in the amount of \$2,800,000 maturing over a 40-year period at an interest rate not to exceed 2.75 percent per annum that will be purchased by USDA/RD. 4. The proceeds from the water revenue bonds shall be used only for the purposes specified in Larue District #1's application. 5. Larue District #1 is authorized to obtain a grant in the amount of \$1,000,000 from USDA/RD. 6. Larue District #1 shall obtain approval from the Commission prior to performing any additional construction not expressly authorized by this Order. 7.
