Schroeder Construction is assessed a fine of \$2,000 for violation of KRS 367.4917(1) for failure to provide the Louisville Gas and Electric Company, the operator of an underground facility serving the public, with notification of its intended work and work schedule not less than two nor more than ten full working days prior to commencing work and for violation of KRS 367.4917(4). 2. Schroeder Construction shall pay \$2,000 within 30 days of the date of this Order by cashier's check or money order payable to the Kentucky State Treasurer and mailed or delivered to the offices of the Kentucky Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky 40601.
