Final Order Entered: 1. Ben Hodges is assessed a fine of \$1,250 for violation of 367.4911(1)(a) for failure to provide the Leitchfield Gas Company, the operator of an underground facility serving the public, with notification of his intended work and work schedule not less than two nor more than ten full working days prior to commencing work. 2. Ben Hodges shall pay \$1,250 within 30 days of the date of this Order by cashier's check or money order payable to the Kentucky State Treasurer and mailed or delivered to the office of the Kentucky Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky 40601. 3. As a first time violator of the Act, Ben Hodges is eligible for mitigation of penalty as established by the Division of Inspections informal policy and past practice by making a payment of \$100 and attending a damage prevention training course to be held at the offices of the PSC at 211 Sower Boulevard, Frankfort, Kentucky on June 7, 2021, at 9 a.m. If Ben Hodges attends the above training course on or before that date and pays a civil penalty in the amount of \$100, the additional \$1,150 assessed against him in numerical paragraph 2 will be vacated.
