Morgan District shall be permitted to use surcharge proceeds to contract with and pay a certified engineer or consultant to draft the plan. 5. Morgan District shall deposit surcharge collections in a separate interest-bearing account. 6. On the 15th day of each month for 48 months from the date of this Order or until all surcharge proceeds are expended, Morgan District shall file with the
	Commission a monthly activity report that includes a statement of monthly surcharge billings and collections; a monthly surcharge bank statement; a list of each payment from the account, its payee, and a description of the purpose; and invoices supporting each payment.
