Duke Kentucky shall submit status update reports on the closure project every three months from the date of this Order, which shall include, among other things, detailed information regarding the amount spent to date, the amount spent during the reporting period, the projected budget for the next reporting period, the total projected cost of the project, construction activities that occurred during the reporting period, and the construction activities for the next reporting period.
