Ledbetter District's commissioners and manager shall attend six hours of certified water

management training by March 31, 2023. 3. Ledbetter District commissioners and manager shall file written notice no later than

May 1, 2023, that they attended six hours of certified water management training by March 31, 2023. 4. Ledbetter District shall file written notice of the adoption of annual tariff reviews no later than August 1, 2022. 5. Ledbetter District shall file written notice on an annual basis of the report of the tariff review conducted by the manager and Ledbetter District commissioners. 6. Beginning with the next billing month after the date of this Order, Ledbetter District shall refund \$7,962.69 to its customers as a surcredit of \$1.11 per bill per month

for six months. 7. Within 15 days of the termination of the surcredit, Ledbetter District shall file with the Commission a summary report with documentation illustrating that the overcollection was returned, any over- or undercollection, and how Ledbetter District

proposes to account for any over- or undercollection.
