Duke Kentucky shall continue to file a DSM application annually by August 15 containing an analysis of the impact of DSM charges on its electric and gas customers' bills, detailed evaluations of the cost-effectiveness of its existing programs, and any proposed revisions to programs in light of the attendant cost burdens to the residential and commercial classes. 4. Within 20 days of the date of entry of this Order, Duke Kentucky shall file with the Commission, using the Commission's electronic Tariff Filing System, revised electric and gas tariff sheets setting forth the rates approved herein and reflecting that they were approved pursuant to this Order. 5.
