The sentence on page 11 of the February 10, 2022 Order reading, "Due to the absence of evidence that the quality of Adair District's service will decline or be degraded as a result of a temporary lower level of revenue than otherwise justifiable, and in recognition of the balance required by the provision of service under KRS 278.030(2) and the impact an increase of this magnitude would have on customers, the Commission finds that a six-year phase-in of rates should be approved." is stricken and replaced with the following sentence: Due to the absence of evidence that the quality of Adair District's service will decline or be degraded as a result of a temporary lower level of revenue than otherwise justifiable, and in recognition of the balance required by the provision of service under KRS 278.030(2) and the impact an increase of this magnitude would have on customers, the Commission finds that a three-year phase-in of rates should be approved. 2. One week prior to the effective date of Phase 2, and one week prior to the effective date of the Phase 3 water rates, Adair District shall publish notice following the requirements of 807 KAR 5:076, Section 5. Within 45 days of publishing the notice required in ordering paragraph number 6, Adair District shall file proof of notice as required pursuant to 807 KAR 5:076, Section 5(3).
