One month prior to the effective date of the Phase 2 rates, Breathitt District shall notify its customers of the implementation of the Phase 2 rates by publishing one-time notice of the increase in a newspaper of general circulation in its territory or placing an insert in bills rendered to its customers. 7. Within 45 days of publishing notice required in ordering paragraph 6, Breathitt District shall file proof of publication of the notice to the Commission as required pursuant to 807 KAR 5:076, Section 5(3) in the post case correspondence, referencing this case number. 8. Phase 3 rates set forth in Appendix B to this Order are approved for service rendered by Breathitt District on and after two years following the date of this Order.
