Payment pursuant to ordering paragraph 1 shall be made by cashier's check or money order payable to Kentucky State Treasurer and mailed or delivered to Office of General Counsel, Kentucky Public Service Commission, 211 Sower Boulevard, Post Office Box 615, Frankfort, Kentucky 40602. 3. The Commission shall waive civil penalty of \$250 for each individual who attends 12 hours of Commission approved training within 335 days of date of service of this Order and provides written notice they attended training within one year of service of this Order. 4. Any written notice provided pursuant to ordering paragraph 3 shall include case number and be maintained in the post-case correspondence file for this case. 5. Any newly adopted or amended policies and procedures for East Casey District as result of this case shall include the case number for this case and be maintained in the post-case correspondence file for this case. 6. East Casey District shall file an application for a general rate adjustment pursuant to 807 KAR 5:001, Section 16, or an application for an alternative rate adjustment pursuant to 807 KAR 5:076, by June 30, 2023. 7. This case is closed and removed from the Commission's docket.
