East Casey District shall file an application for a general rate adjustment pursuant to 807 KAR 5:001, Section 16, or an application for an alternative rate adjustment pursuant to 807 KAR 5:076, by June 30, 2023. 7. This case is closed and removed from the Commission's docket.
