EKPC's request to move the centerline 30 feet from structure BM069 and BM070 is approved so long as no new property owners are affected. 3. EKPC shall file a survey of the final location of the transmission facilities after any modifications are finalized as authorized by this Order and before construction begins. 4. EKPC shall notify the Commission upon knowledge of any material changes to the project, including but not limited to, increase in cost, any significant delays in construction, or any changes in the route of the transmission line not expressly

by his Order. 5. EKPC shall file as built drawings and maps within 60 days of the completion of the construction authorized by this Order.

6. EKPC shall furnish documentation of the total costs of this project including the cost of construction and all other capitalized costs, including, but not limited to, engineering, legal, and administrative expenses, within 60 days of the date construction of the transmission line
