06/01/23 Final Order Entered: 1. BREC is granted a CPCN to construct its new TOC as proposed in its application. 2. BREC shall immediately notify the Commission upon knowledge of any material changes to the project, including, but not limited to, increase in cost and any significant delays in construction. 3. Any material deviation from the construction approved by this Order shall be undertaken only with the prior approval of the Commission. 4. BREC shall file with the Commission documentation of the total costs of the projects, including the cost of construction and all other capitalized costs, within 60 days of the date that construction authorized under this CPCN is substantially completed. 5. BREC shall file a copy of the "as-built" drawings and a certified statement that the construction has been satisfactorily completed in accordance with the contract plans and specifications within 60 days of the substantial completion of the construction certificated herein. 6. Any documents filed in the future pursuant to ordering paragraphs 4 and 5 herein shall reference this case number and shall be retained in the post-case correspondence file. 7. BREC's application requesting approval of the transfer of ownership of its existing ET&S facility is granted on conditions that: a. BREC proceeds with construction of the new headquarters as proposed herein; and b. The sale price of the existing ET&S facility is not less than its remaining net book value at time of the transfer.
