A hearing in this matter shall be held on January 4, 2024, at 9 a.m. Eastern Standard Time and continuing until called from the bench by the presiding officer, in the Richard Raff Hearing Room at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky, to examine the application of the Fuel Adjustment Clause of Jackson Purchase Energy Corporation, Kenergy Corp., and Meade County Rural Electric Cooperative Corporation (collectively, Cooperatives or individually Cooperative) from November 1, 2020, through October 31, 2022. If no interested party files written notice of its intent to attend this hearing with the Commission by December 27, 2023, this public hearing shall be canceled and the matter shall be considered submitted for decision based on the evidence in the record. 2.
