Within 20 days of the date of service of this Order, LG&E shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rate approved herein and reflecting that it was approved pursuant to this Order. 4. On or before May 12, 2023, LG&E shall file its responses to the Commission Staff's First Request for Information attached to this Order as Appendix B. 5. LG&E shall respond to any additional requests for information propounded by Commission Staff as provided in those requests. 6. This case is closed and removed from the Commission's docket.
