The time in which the Commission shall render its decision on the application is continued an additional 60 days from July 25, 2023, to September 23, 2023, pursuant to KRS 278.020(7). 2. The procedural schedule set forth in the Appendix to this Order shall be followed. 3. Parties shall respond to all requests for information propounded by Commission Staff, whether identified on the procedural schedule or otherwise, as provided in those requests. 4. Any party filing a paper with the Commission shall file an electronic copy in accordance with the electronic filing procedures set forth in 807 KAR 5:001, Section 8. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.
