The Commission shall waive the civil penalty of \$500 for each individual, Troy Norris, Eric Carver, Jay Cary, and Matthew Dyer, who attends a total of 12 hours of Commission approved training in calendar year 2024 and 2025, in addition to any other required yearly training and any other Commission ordered training, and provides written notice that they attended the training within 30 days of attendance. 6. Any written notice provided pursuant to ordering paragraphs 5 or 6 shall reference this case number and shall be retained in the post-case correspondence file.
