Valley Gas is ordered to refund \$3,473.41 in erroneously collected late fees to affected customers within 90 days of service of this Order. Valley Gas shall make reasonable efforts to locate any customers due refunds who are no longer Valley Gas customers. Valley Gas shall comply with KRS Chapter 393A regarding unclaimed property. 3. For the reasons set forth above, Valley Gas is assessed a civil penalty of \$25,000, suspended in total, if Valley Gas complies with this Order regarding its obligation to issue refunds and commits no further willful billing violations within five years

of service of this Order. 4. This case is closed and removed from the Commission's docket.

If Valley Gas is unable to make such demonstration, the requested material shall be made available for inspection. Otherwise, the Commission shall deny the request for inspection. 6. The Commission shall not make requested material available for inspection
