Mountain District is authorized to use water loss surcharge funds to pay the wages and benefits of the two new employees for the daytime leak detection crew for a total cost amount not to exceed \$45,240 per employee per year. 3. Mountain District shall file an application for a general rate adjustment based on its most recent annual report on file prior to the exhaustion of water loss surcharge funds. Mountain District shall consider the statements made in the amended QIIP in the filing. 4. Mountain District is authorized to use water loss surcharge funds for the purchase of two half ton pickup trucks as described in its motion filed on December 2, 2024, at a total cost not to exceed \$80,000. 5. Mountain District is authorized to use water loss surcharge funds for the purchase of a one ton truck, trailer, and compact excavator as described in its motion filed on December 2, 2024, at a total cost not to exceed \$114,000.

Mountain District is authorized to assess a surcharge of \$1.72 per customer over 48 months, or until \$1,365,608 has been assessed, whichever occurs first. 2. Mountain District's motion is granted. 3. Mountain District's request to modify the day on which the District must submit its monthly surcharge and water loss reports to the last day of each month is granted. 4. The October 31, 2023 Order, as amended herein to reflect the amendment by Order issued on November 29, 2023, in Case No. 2022-00366, is clarified to the extent that Mountain District is authorized to assess a Water Loss Reduction Surcharge for a 48-month period, beginning January 2024 and ending December 2028, or until \$1,365,608 has been assessed, whichever occurs first. 5. The October 31, 2023 Order, as amended herein to reflect the amendment by Order issued on November 29, 2023, in Case No. 2022-00366, is clarified to the extent that Mountain District shall file its first annual report of surcharge activity and water loss improvement progress no later than April 30, 2025. 6. All provisions of the October 31, 2023 Order, as amended herein to reflect the amendment by Order issued on November 29, 2023, in Case No. 2022-00366, that are not in conflict with the terms of this Order, shall remain in effect.

10/31/23 Order Entered: 1. This case is opened to monitor Mountain District's Water Loss Reduction Surcharge proceeds and collections. 2. The record of Case No. 2022-00366 is incorporated by reference in this proceeding. 3. Within 120 days of the date of service of this Order, Mountain District shall file with the Commission a QIIP, including a comprehensive unaccounted-for water loss reduction plan that establishes priorities and a time schedule for eliminating each source of unaccounted-for water loss and provides a detailed spending plan for the proceeds of a surcharge. Mountain District's QIIP shall also detail what infrastructure projects it proposes for use of the KIA Clean Water Grant (No. 22CWW069) and American Rescue Plan Act funds. 4. Mountain District shall deposit surcharge collections in a separate interest-bearing account. 5. On the 15th day of each month for 48 months from the date of service of this Order or until all surcharge proceeds are expended, Mountain District shall file with the Commission a monthly activity report that includes a statement of monthly surcharge billings and collections using the Surcharge Reporting form that can be found at <https://psc.ky.gov/Home/UtilForms>
