LG&E is authorized to incur indebtedness in an aggregate principal amount, not to exceed \$1.150 billion in the form of one or more privately placed or publicly issued, secured or unsecured, debt securities or obligations, which may include first mortgage bonds, medium or long-term notes, term or bank loans and similar securities or obligations, in one or more series from time to time, which may include loans or obligations granted, facilitated or guaranteed by the United States Department of Energy, United States Treasury or other governmental authorities, or tax exempt or tax advantaged bond issuances facilitated by federal, state or local governmental authorities, or any combination thereof through December 31, 2027. 2. LG&E is authorized to enter into the interest rate hedging agreements in connection with the New Long-Term Debt as set forth in LG&E's application. 3. LG&E is authorized to establish regulatory assets or liabilities for accounting purposes for any resulting mark-to-market losses or gains and to amortize the gains and losses over the remaining life of the New Long-Term Debt as set forth in LG&E's application. 4. LG&E is authorized to exercise an extension and maintain its revolving credit line and to extend its existing or new revolving line(s) of credit through December 31, 2027, for up to five years from the date of each amendment date in an amount up to \$750 million.
