Within 20 days of the date of service of this Order, Ohio District shall file with the Commission revised tariff sheets containing the approved rates. 5. Ohio District shall collect any under collection or issue any refund, over a period of no less than 11 months, for any difference between the rates for retail water service placed into effect following the February 18, 2025 Order, and the rates provided in the Appendix to this Order. 6. Within 20 days of the date of this Order, Ohio District shall file in this case a statement detailing the amounts billed to its retail customers lesser than the rates authorized in this Order with totals for each type of charge separately stated.

No later than the date set forth in the procedural schedule, Commission Staff shall file with the Commission and serve upon all parties of record a written report (Commission Staff's Report) containing its recommendations regarding Ohio District's requested rate adjustment. 5. No later than 14 days after the date of service of the Commission Staff's Report, each party of record shall file with the Commission: a. Its written comments on and any objections to the findings contained in the Commission Staff's Report; and b. Any additional evidence for the Commission to consider. 6. If Commission Staff recommends that Ohio District's financial condition supports a higher rate than Ohio District proposes or the assessment of an additional rate or charge not proposed in Ohio District's application, Ohio District in its response to the Commission Staff's Report shall also state its position in writing on whether the Commission should authorize the assessment of the higher rate or the additional rate or charge.
