Rattlesnake Ridge District's Water Loss Reduction Surcharge proceeds and collections.  
3. The record of Case No. 2023-00338 is incorporated by reference in this proceeding. 4. Within  
120 days of the date of service of this Order, Rattlesnake Ridge District shall file with the Commission  
a qualified infrastructure improvement plan, including a comprehensive  
unaccounted-for water loss reduction plan that establishes priorities and a time schedule for eliminating  
each source of unaccounted-for water loss and provides a detailed spending plan for the proceeds of a  
surcharge. 5. Rattlesnake Ridge District shall deposit surcharge collections in a separate interest-  
bearing account.
