06/30/25 Final Order Entered: 1. The continuation of Atmos' PBR mechanism is approved and effective on the date of this Order through March 31, 2027. 2. In the next PBR case, Atmos shall file an evaluation report on the results of the PBR from April 1, 2021, through the most recent month available at the time of filing, for the Commission to review and determine whether the PBR should be continued, modified, or terminated. This evaluation report shall be considered in any proceeding established to continue, modify, or terminate the PBR mechanism. 3. In the next PBR case, Atmos shall also file testimony and any supporting documentation to assist the Commission in determining whether Atmos's PBR should be continued, modified, or terminated. 4. Any request for extension of Atmos's PBR shall be filed no less than four months before the March 31, 2027, expiration date. 5. When filing its future PBR reports, Atmos shall provide additional supplemental information of the information presented along with a monthly breakdown of the costs or savings for each basic component of its PBR. Atmos shall also provide information regarding the benchmarks used and the costs associated with the gas costs used against such benchmarks. 6. When filing its future PBR reports, Atmos shall file a version in Excel spreadsheet format, with all formulas, columns, and rows unprotected and fully accessible.
