07/12/24	Order Entered: 1. This proceeding is established to investigate the reasonableness of the proposed tariff. 2. Mt. Vernon's proposed tariff is suspended for five months from July 16, 2024, up to and including December 15, 2024. 3. Mt. Vernon shall, by counsel, enter an appearance in this proceeding within seven days of the date of service of this Order. The entry of appearance shall include the name, address, telephone number, fax number, and electronic mail address of counsel. 4. Unless otherwise ordered by the Commission, the procedures set forth in 807 KAR 5:001, Section 8, related to service and electronic filing of papers shall be followed in this proceeding. 5. Pursuant to 807 KAR 5:001, Section 8(10), unless a timely objection is filed, within seven days of the date of service of this Order, Mt. Vernon shall file by electronic means a written statement that it waives any right to service of Commission Orders by United States mail and that it or its authorized agent possess the facilities to receive electronic submissions. 6. Unless a party granted leave to intervene states its objection to the use of electronic filing procedures in a motion for intervention, the party shall: a.
