Duke Kentucky shall file quarterly reports as set for in this Order beginning 30 days after the first quarter of participation in PJM as a RPM entity to include each BLI line item, if a penalty an explanation of the infraction and for each BLI line item, the amount. 5. Duke Kentucky shall file the BLI statements from PJM on a monthly basis for the first year it participates in the RPM construct. 6. Documents filed pursuant to ordering paragraphs 3–5 herein shall reference this case number and shall be retained in the post-case correspondence file. 7. The Amendments to the Rider PSM Tariff approved by the Commission in this Order shall only be effective coincident with the first day in which Duke Kentucky operates under the RPM construct. 8. Duke Kentucky's request to include BLIs 1610; 1650; 2605; 2620; 2625; 2630; 2640; and 2650; in the Rider PSM is approved. 9. Duke Kentucky's request to include BLIs 1660, 1661, 1662, 1663, 1664, 1665 and 1666 and 2660, 2661, 2662, 2663, 2664, 2665, and 2666 in the Rider PSM is denied.
