If Kentucky Power files notice of its intention to place the proposed tariff into effect after the end of the suspension period, Kentucky Power shall maintain its records in such manner as will allow it, the Commission, or any customer to determine the amounts to be refunded and to whom in the event a refund is ordered upon final resolution of this matter. 5.
