The NANPA and the telecommunications providers shall file a new proposed implementation schedule at the earlier occurrence of either the publication of revised exhaust dates in April 2026 or if the available central office codes reach 40 or less.

07/31/25	Order Entered: 1. The methodology selected for the 502 NPA relief plan within Kentucky shall be by an all-services distributed overlay as described herein. 2. Network preparation for the overlay implementation is estimated to begin June 1, 2026. The permissive ten-digit dialing period is estimated to begin no later than December 7, 2026, and mandatory ten-digit dialing is estimated to begin no later than June 7, 2027. 3. The effective date of the new area code, or earliest date a CO code activation from the new area code may occur, is estimated to be no later than July 5, 2027. 4. All existing EAS dialing arrangements, which allow customers outside the boundaries of the 502 NPA to complete cross-boundary calls between area codes by dialing seven-digits, shall require ten-digit dialing across the 502 and new area code boundary. 5. Within 60 days from the date of service of this Order, each ILEC, CLEC, and wireless provider shall file its proposed customer education plans to the Commission.
